_____	<b>Professional Standards</b> Deadline: November 30 <sup>th</sup> <i>Members must have been a REALTOR® for at least five (5) years.</i>	To encourage strict adherence to the REALTORS® Code of Ethics by all members and to conduct Hearings as referred by the Grievance Committee and/or the Board of Directors concerning possible violations of the code of ethics and/or commission disputes arising out of the closing of real estate transactions.
_____	<b>Awards</b>	To review rules and examine applications for the Million Dollar Club, and to qualify them for approval by the Board of Directors. Additionally, this Committee will select the Realtor of the Year and the Affiliate of the Year in November.
