MEMBERSHIP REQUIREMENTS

1. A completed membership application submitted to the Board.
2. Membership fees must be paid.
3. Completion of a qualified New Member Code of Ethics course within 6 months of submitting your application to the Board. For more information, please visit www.pickensrealtors.com/orientation.

Note to Designated REALTORS® - Fees must also be paid per licensed agent within the company. Paying fees on agents within an office does not automatically qualify them for membership; each agent must complete an application and fulfill all necessary requirements.

PCBR DESIGNATED REALTOR® / REALTOR® FEE INFORMATION

Annual membership dues for the Designated REALTOR® are calculated at \$465. Each licensed agent within the Designated REALTORS® office will also pay \$465 in order to become a REALTOR® member of the Board. All agents applying to the Board must pay dues, fill out an application and complete all new member training requirements before being approved for full membership.

The portion of dues paid that is spent to lobby the State and Federal governments is not deductible for income tax purposes. GAR has estimated that \$8.31 (8.38%) is the nondeductible portion of the 2021 GAR dues. NAR has estimated the nondeductible portion of its 2021 dues to be \$57.00 (or 38%). The entire \$35.00 NAR Public Advocacy Campaign Assessment qualifies as deductible dues.

DESIGNATED REALTOR® - Defined as the Principal, Partner, Corporate Officer, Trustee, or Branch Manager of a Real Estate firm. There is only one Designated REALTOR® per company. The Designated REALTOR® is responsible for paying fees for all licensed agents within his or her organization.

REALTOR® - Defined as any agent within the office of a Designated REALTOR® that holds an active real estate license who becomes a member of the Board.

If applicant completes the Code of Ethics course within 6 months of application to the Board, the effective date shall be the date the application was received in the Board Office.

CONSENT AND AUTHORIZATION

In the event of my election, I agree to abide by the Code of Ethics of the National Association of REALTORS®, including the obligation to arbitrate any existing or future disputes with another member in accordance with the Board's arbitration procedures. I also agree to abide by the Constitution, Bylaws, and Rules and Regulations of the Pickens County Board of REALTORS®, the Georgia Association of REALTORS®, and the National Association of REALTORS® which are made available to me at the office of the Pickens County Board of REALTORS®, and if required, I further agree to satisfactorily complete within 6 months, a Code of Ethics course. I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws, Rules and Regulations, and duty to arbitrate, all as from time to time amended. I irrevocably waive all claims against the Board or any of its officers, directors or members, for any acts in electing or failing to elect, advancing, suspending, expelling, or otherwise disciplining me as an applicant, or as a member. Upon the expiration of said membership for any cause, I will discontinue the use of the term REALTOR® and return to the Board all certificates, signs, seals or other indications of membership in the Board, the State Association and the National Association of REALTORS®. I consent that the Board, through its Membership Committee or otherwise, may invite and receive other information and comment about me from any member or other person, and I further agree that any information and comment furnished to the Board by any person in response to the invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

I agree that, if accepted for Membership in the Board, I shall pay the fees and dues as from time to time established. I understand that should I not complete the Code of Ethics requirement within the prescribed 6 months from the date of my application that I will be automatically dropped as an applicant for membership and that there will be no refund of any portion of the fees paid. I hereby certify that the foregoing information furnished by me is true and correct, and I agree that failure to provide complete and accurate information as requested, or any misstatement of fact, shall be grounds for revocation of my membership if granted.
